## MINUTES FOR RECREATION COMMISSION MONTHLY MEETING - MARCH 4, 2015

## **OPEN PUBLIC PARTICIPATION**

## **Kerry Seribo Graham and Janet Boyhen**

Made a request to begin a track and field program for children aged 7-14 years old. The program is affiliated with the New Jersey Striders and the USA Track and Field Program. They have requested practice time at the High School 2-3 times per week @ approximately  $1 - 1\frac{1}{2}$  hours. Season starts in March and continues through May. Would like to include Haworth residents as their program was recently disbanded. Registration fee would be \$75 per child.

## **Brian Nallen - Dumont Junior Football**

Came to meeting to introduce himself to the Commission as the newly elected President of DJF. New executive board has been elected. Officers list will be made available to their liaison.

## **Tony Como – Dumont Senior Baseball**

Registrations were good this year. Noted that the carpet in the batting cage was in disrepair. Requested we forward information to Mike Oppido at the High School. Fundraiser/tricky tray for 18U team to be held March 21 at the KoC. Is hoping to go with teams to the Rockland Boulder facility as last year was a success. Also requesting \$250 for tourney entry, as was done last year.
