TO OUR CUSTOMERS:

PLEASE TAKE NOTICE that, on June 22, 2022, Veolia Water New Jersey, Inc. ("Veolia NJ" or the "Company"), pursuant to P.L. 2021, c. 183, filed a petition with the New Jersey Board of Public Utilities ("BPU" or "Board"), for approval to defer the costs related to the replacement of customer/property owner-side lead service lines ("LSL") and other related approvals ("Petition"). By the Petition, the Company proposed deferred accounting to recover all monies prudently invested to replace LSLs in its service areas during the timeframe directed by the legislature.

As described in the Petition, most buildings receiving water service from a water system are connected to that system through a "service line," which usually consists of two portions: a 'company-side' portion which connects the water main (usually in the street) and a non-company-owned portion connected to the building receiving water service. The non-company-owned portion of the service line is owned and controlled by the owner of the building connected by the service line. Many of these service lines have been discovered to contain lead or other problematic substances. P.L. 2021, c. 183 mandates a 10-year timeframe for the replacement of such problematic service lines in New Jersey, and provides that, in a company's next rate case before the Board, a plan should be implemented consistent with that law for cost recovery of non-company-side LSL replacement costs.

By the Petition, the Company requests that the BPU approve a plan to account for, and defer on its books, expenditures relating to its LSL replacement program pending a BPU decision in the Company's next rate case.

The specific multi-year LSL replacement program will be filed as part of the Company's next full rate case, However, due to the required statutory timeframe, the Company began the LSL replacement process before a detailed plan could be presented to, and approved by, the Board. By this request, the Company will be able to fully account for the costs of whatever program the Board ultimately approves. Veolia NJ anticipates this Petition will incur no customer rate impact at this time.
