- 4. NJ Tree Federation Annual Conference: Oct. 26 & 27, Cherry Hill, NJ Core Training --Report from John and Stephanie Very valuable conference
- 5. Davies Tree Survey—update, training was held virtually on Nov. 1. The web-based program, Treekeeper, is very inclusive and detailed. Not sure who is inputting data from the borough. Need to get DPW on board for data entry and updates. Volunteer Final hrs submitted to Boro Admin, Google Sheet submitted TOTAL 342.5 hrs! for Grant Reimbursement from NJ State.
- 6. Homeowner Issues/Borough Tree Issues, Tree Removals on List/Risk Assessment Plan and Inclusion of Sidewalk Remediation—Accepting Adopt-a-Tree applications for Spring 2024. Most will likely be from tree removals due to sidewalk issues. Planning for 10+ trees. Will need to get on the schedule with NJ Tree Foundation if we want to use their resources for planting.

Action item: can we buy our own trees? Perhaps from Rosedale Nurseries, Hawthorne NY.

Recent request for 92 Lexington, 1 removal in ROW and will accept 3 Adopt-a-Trees.

7. Monthly Arboretum Inspections-Dec., Tom can report.

FOTST Report: Garden beds-cleaned up & bulbs planted Nov. 4, will need volunteers for 2024. Really need a garden bed manager.

- Arboretum mostly in good shape
- All beds have number signs. DPW needs to remove the pile of debris by bed 9. Beds need caretakers, we need a manager. Some beds ok. Bed 9 not in good shape. Bed 7 also needs work, TLC.
- We need a spring cleanup date.
- Tom will sand the bench in the Spring
