



Important Reminder About Ongoing Recall

July 1, 2019

Dear Valued Fire Service Professional:

As previously communicated, Kidde, in conjunction with the U.S. Consumer Product Safety Commission (CPSC), announced a recall in 2017 to replace certain Kidde fire extinguishers. The CPSC is monitoring the effectiveness of this recall. Another copy of the safety notice is enclosed for your records. Kidde has also sent a copy of this notice to our retail customers with instructions to repost the safety bulletin in locations that sold these extinguishers.

We value our relationship with the State Fire Marshals and NASFM and would appreciate you spreading the word about this important ongoing safety recall in your fire safety efforts.

As communicated in 2017, this replacement program was initiated because certain fire extinguishers can become clogged or require excessive force to activate, posing a risk of failure to discharge. In addition, the nozzle can detach with enough force to pose an impact hazard.

As the safety of our customers is our priority, we have worked over the last 19 months to obtain all recalled units and provide replacement options. However, we want to ensure the broadest reach possible as we continue to carry out the recall of the following two styles of Kidde fire extinguishers:

Plastic handle fire extinguishers: The 2017 recall involves 146 models of Kidde fire extinguishers manufactured between January 1, 1973, and August 15, 2017, including some models that were previously recalled in [March 2009](#) and in [February 2015](#). The extinguishers were sold in red, white and silver, and are either ABC- or BC-rated. Models are as follows:

Push-button Pindicator fire extinguishers: Eight models of Kidde fire extinguishers manufactured from August 11, 1995, through September 22, 2017. The no-gauge push button extinguishers were sold in white and red and with a red or black nozzle. These models were sold primarily for kitchen and personal water craft applications. Models are as follows:

Metal handle/valve fire extinguishers are NOT included in this ongoing recall. The unaffected models include the Kidde Professional line, Badger branded extinguishers and the recently introduced disposable Metal Valve Extinguishers.
