1. Wilfred Dunn, 44 Thompson Street, complained about an environmental issue he had complained about in 1986 that was never addressed. On the corner of Thompson and Magnolia there are four catch basins, which have existed for 101 years, with no exit pipe. It has caused his sidewalk to sink. Mr. Herr and the engineer will look at it.

2. Bruce deLyon, 67 Beacon Street, asked about the Quackenbush properties spoken about at the last meeting. The Mayor explained that we are now looking at two other properties on Quackenbush as an alternative. Dr. deLyon asked about environmental issues and demolition cost at the Quackenbush properties. What is the status of the contract of the Administrator/CFO? The Mayor stated the negotiations are ongoing; they will be discussed with the personnel committee first.

3. Chris Sheridan, 9 Wilcox, asked if anyone spoke to Fair Share Housing about our obligation? Councilman Geist responded that the website has the old number still up. He contacted several people and was finally told that everything has to go through the Borough Attorney because it's still in litigation. Mr. Sheridan asked if the Councilman could get the transcript from the fairness hearing. The Councilman said he would try. Mr. Sheridan asked if we have received an environmental remediation plan. The Mayor replied that that would be a question for the Joint Land Use Board. He asked what "E" means on the plans-Egress.

4. Lili Binney, 32 Roxbury Road, asked if there was an engineer at the Joint Land Use Board meeting. Councilman Geist said he was there but the architect was the only one who had time to present testimony. Ms. Binney asked if the town could pay for the May fairness hearing transcript. She asked if Mr. Egenhofer knew when FSH will put out new numbers reflecting the most recent decision on the gap calculation. He does not know. Ms. Binney asked about Resolution 16-248 and when the overlay zone will come up for another vote; has the appendix been found? She asked if it was legal. Why are

we considering an overlay zone? Has the Council considered a set aside ordinance for residential 5+ units instead of the overlay? What number of credits will the overlay satisfy? The Mayor replied the unmet need is 83 until 2027. Will historic sites be designated?

5. Maryann Russini, 141 Roosevelt, asked Mr. Herr for the amount it is costing us for D'Angelo's. The Mayor explained that they are currently working on the budget so this is another project. Every bill would have to be researched to see if it had to do with D'Angelo's. Ms. Russini said Plan B would be to ask if Mr. Paster's bills could be looked at for D'Angelo's

6. Karen Valido, 24 Overlook Drive, mentioned fees in the settlement agreement. She is concerned about the PILOT, environmental issues and the number of children that would result from the D'Angelo's project. Who would be overseeing the soil at 50 Washington Avenue? The Mayor replied the engineer and LSRP would. Ms. Valido asked if there is any soil contamination or tanks on the Quackenbush properties. The Mayor responded that they don't know yet. Ms. Valido asked about tax increase. Mr. Herr said they will be having a meeting tomorrow to discuss the financing of the potential complex. There are a lot of variables.

Councilwoman Correa asked for clarification on our responsibility of soil remediation is necessary at 50 Washington Avenue. She also asked about renovating the old borough hall. Mayor Kelly replied that it is the engineer's opinion that the building is in very bad shape and the cost to rehabilitate it would be the same, if not more. The Councilwoman asked when we would be meeting with the architect. The Mayor responded that the architect who has been working on the plans just left on an emergency medical leave so there is now someone new has been assigned to the project. She said she remembered Councilman Riquelme asked the cost of doing the rehab study. The Councilman clarified that he would like to have the architect provide a cost for doing the study.
