ARBORETUM REPORT October 2019 FROM Abbie Slaman:

General:

Garden Beds looked good, well tended and planted, thanks to the volunteers and their work.

Trash:

Minimal clean-up was required at northern end.

Mature Trees:

Large pin-oak has crossed limb which needs to be removed before it compromises the structure of the one it rests upon. This has been reported for several years

Knock-out Roses:


Have been suffering from poor pruning techniques. Please refer to https://www.knockoutroses.com/faqs for proper care. Chain saws are not correct pruning tools. Clean, sharp, pruning tools must be used. Also, deadheading is not necessary for Knock-out Roses. Some plants have crushed or mangled canes and some plants have died.






Gazebo:

The box for the Buy-a-Brick flyers is empty.




The QR code leads to a non-existent web page.
