3. Maryanne Russini, Roosevelt Avenue, thanked Councilman Chae for everything he did.
4. Jennifer Winant, Magnolia Avenue, asked if town has indemnification insurance regarding OPRA's and wouldn't town be held responsible?

Administrator Tully stated the \$44,000 was related to the flood damage in July. The individual who offered their livestreaming services for free was primarily for town events. We do have the equipment here at Borough Hall to livestream the meetings. Unfortunately, it did require a specific fix by JCT and Dart Computer. Based on communications yesterday, it should be up and running when we return to in person meetings.

Attorney Leibman commented on the penalties that can be imposed upon the Clerk if OPRA's are not answered properly. There are also attorney fees that get imposed upon

the public entity that failed to produce the documents. The Government Records Council in Trenton has their common law on their website. However, the GRC's decisions are not always upheld in higher courts. It's a very complicated area. The Clerk is responsible for the fines, but the town is responsible for the legal fees.

Councilman Harvilla is looking to create a balance and comprehensive approach to the overall impact of the Economic Development Committee and the Joint Land Use Board in concert with our financial needs with fiscal requirements and infrastructure improvements, as well as existing and future master plans for the Borough of Dumont. It encompasses complex economic, logistical and environmental issues.

Councilman Chae wished everyone a Happy New Year and stated it's been an honor and pleasure to serve the town of Dumont as a Council person for the past three years. The first year was a learning curve, through the pandemic and the final year. He wishes the new council members nothing but great success. He will still be serving the town as much as he can.


Mayor LaBruno thanked Councilman Chae and Councilman Englese for their service and for the past three years.

Councilwoman Rossillo congratulated everyone on Sunday's Swearing-In Ceremony. She apologized for not attending, as her family was ill, but is thankfully all recovering now. She wishes everyone the best. The Councilwoman welcomed the new Council members, Mary and John aboard. She thanked all of the police officers and members of the fire department for their service.
