An Ordinance of the Borough of Dumont, County of Bergen, State of New Jersey
ORDINANCE AMENDING CHAPTER 21, SECTION 31.1 OF THE BOROUGH OF
DUMONT CODE CONCERNING HANDICAPPED PARKING

WHEREAS, N.J.S.A. 39:4-197.5 authorizes a municipality to establish a restricted parking space in business districts for use by persons who have been issued special vehicle identification cards by the Division of Motor Vehicles pursuant to the provisions of section 2 of P.L.1949, c. 280 (C. 39:4-205), when using a motor vehicle on which is displayed a certificate, for which a special vehicle identification card has been issued, pursuant to section 3 of said law (C. 39:4-206);

WHEREAS, the owner of a business about to relocate to 52 Grant Avenue has made a request that the Borough designate one parking spot in front of the building at that address as a reserved handicapped parking space in order to accommodate patients visiting the eye care office about to relocate to said address;

WHEREAS, the Dumont Police Department has considered the request and has recommended that such request be granted;

THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Borough of Dumont in the County of Bergen and State of New Jersey that Chapter 21, Section 31.1 of the Borough Code of the Borough of Dumont shall be amended as hereinafter provided:

Section B: One parallel handicapped reserved spot shall be and is hereby authorized pursuant to N.J.S.A. 39:8-1 at or near 52 Grant Avenue.

The Municipal Engineer shall determine whether or not said parking space and sign(s) erected in connection with same conform to the current standards prescribed by the Manual of Uniform Traffic Control Devices for Streets and Highways, adopted by the Commissioner of Transportation, and any other Department of Transportation rules and regulations governing such parking spaces and signs.

The Municipal Engineer, under the engineer's seal as a licensed professional engineer, shall certify to the commissioner that the parking spaces and signs:

a. have been approved by the municipal engineer as a licensed professional engineer after investigation; and

b. conform to the current standards prescribed by the Manual of Uniform Traffic Control Devices for Streets and Highways, as adopted by the commissioner, and any other Department of Transportation rules and regulations governing such parking spaces and signs.

The municipal engineer shall submit to the commissioner, together with the engineer's certification, detailed information as to the location and number of parking spaces, a certified copy of the ordinance, resolution or regulation designating the restricted parking spaces, and such other information as the commissioner shall deem necessary.

Invalidity. If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision or clause of this Ordinance.

Severability. All ordinances or parts of ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

Effective Date. This Ordinance shall take effect upon final passage and publication pursuant to law.
